



YOUNG PROFESSIONALS FORUM 2024 REGULATION

DEFINITIONS

- **Event/Forum:** the event entitled "Cultural Accessibility: Principles and Methodologies for Cultural Heritage", which will take place in hybrid form on a virtual platform and will start from 24 September 2024 to 27 September 2024, with the Final Event on 27 September 2024 to be held on Zoom link. The link to connect to the Final Event will be available online on the JRC website and on the [CCR Digital Lab](#) platform and widely shared through the communication channels of the organizing body (email and social media) as well as the partners involved;
- **Expert:** each of the professionals in the field of Cultural Heritage who will play the role of Expert Professional for the related activity Experts meeting as well as all professionals involved in the activities in presence provided by the program;
- **Candidate:** anyone who has correctly completed the form and submitted the documentation relating to the *Call for Training* for the application for a scholarship;
- **Participant or Registered for the Event/Forum:** anyone who has completed the purchase indicating correct and truthful data and paid the fee of € 350 through the [CCR Digital Lab](#) platform or who is entitled to exemption from payment for the addition of scholarship;
- **Promoter:** the Fondazione Centro Conservazione e Restauro dei Beni Culturali La Venaria Reale (<https://www.centrorestaurovenaria.it/>).

Art. 1 – Registration and purchase via CCR Digital Lab platform

1.1 Registration for the CCR Digital Lab platform is mandatory for anyone interested in purchasing the Forum program. Once the registration is complete, the user must proceed with the purchase of the program and correctly complete the payment of the fee of 350 euros. The purchase of the Forum package entitles you to: Participate in the activities in presence from 24 to 27 September 2024, receive the final report in digital version, receive the certificate of participation that will be issued at the end of the activities, book (if of interest) an *Expert Meetings* (From 24th to 27th September there will be *Expert meetings* in presence while from 29th September there will be *Expert meetings* online).

Those who purchase the Forum program will have to pay for the costs of travel, food and accommodation independently. The purchase of the Forum program implies acceptance of the following regulations in all its parts.



1.2 Those who are interested in participating in the Call for Training to obtain a scholarship to cover the total cost of the course, travel, food and accommodation are NOT obliged to enroll in the CCR Digital Lab platform (Registration is mandatory for those who decide to purchase the program).

Applicants interested in the scholarship are required to complete the appropriate online form (available on the CCR website and with appropriate reference also on the CCR Digital Lab platform) by entering correct and truthful information.

- 2.2** Once the form has been completed and submitted, it is possible to purchase the Forum program and complete the payment on the Digital Lab platform with the forms of payment allowed by e-commerce (credit card or Pay Pal).
- 2.3** If the subscriber does not participate in one or more activities for reasons not attributable to the promoter institution, the latter will not be required to pay any refund.

Art. 3 – MEET- *Expert meetings*

- 3.1** Those who have purchased the Forum program, scholarship winners all those who will take part in the final event of 27 September 2024 both online and in presence interested in attending an *Expert Meetings* (the above activity is not mandatory) must fill in the appropriate fields of the dedicated form shared by email by the Promoter and that will be sent following the payment of the purchase fee of the Forum program, scholarship assignment or after attending the final event of September 27, 2024. In particular this activity is aimed at: the winners of scholarships, those who have purchased the Forum program and all those who will follow the final event of September 27 in presence or online. Meetings with experts are available subject to availability.
- 3.2** The promoter will select, among the first 3 members who will be booked for each expert.
- 3.3** The selected will receive an e-mail confirming the successful selection, containing the instructions for participation in the *Expert Meetings* (date, time and instructions to attend the meeting in presence or online).

Art. 4 - Scholarships-Call for Training

- 5.1** Those who are interested in participating in the *Call for Training* to obtain scholarship to cover the total cost of the course, travel, accommodation and board are required to fill in the appropriate online form (available on the CCR website and with appropriate reference also on the CCR Digital Lab platform) by entering correct and true information.
- Interested parties can apply for a *Call for Training* from 26 June 2024 and **no later than 31 August 2024**, to access the Form program. The activities will be held in the presence in the Centro Conservazione e Restauro "La Venaria Reale" to be held from 24 to 27 September 2024.
- 5.2** A Jury of experts will be in charge of evaluating the applications, and to identify at its sole discretion the most suitable profiles for this activity.
- 5.3** There are 4 places (scholarships) for total coverage to access the Forum program sponsored by the Magnetto Foundation. The Promoter will notify the candidate by email of the success or not.



5.4 There are 3 places (scholarships) to total coverage to access the Forum program sponsored by the Associazione Amici della Reggia e del Centro di Restauro "La Venaria Reale" reserved for graduates or university students of the Degree Course in Conservation and Restoration of Cultural Heritage of the University of Turin and the Centro e Conservazione e Restauro "La Venaria Reale" (CCR).

The Promoter will notify the candidate by email of the success or not.

5.5 The winners of the *Call for Training* will benefit from a training experience at the Centro Conservazione e Restauro "La Venaria Reale" to be held on 24, 25, 26 and 27 September 2024. The scholarship will guarantee the full coverage of the cost of the course, the accommodation of the participants, the A/R travel expenses and the food . Anything that is not included in the above item will be borne by the winner.

5.6 The safety rules and procedures for carrying out the activity will be determined in a manner compatible with the health measures imposed by the pandemic.

Art. 6 – Changes to the planning of the Event

6.1 The Promoter reserves the right to unilaterally change the programming of the Forum.

6.2 The Promoter reserves the right to unilaterally change the programming of the Forum.

6.3 In the event that the Forum Event cannot be held or should be postponed by chance or force majeure or events in any case not attributable to the Promoter, the latter cannot be held responsible for any loss or damage suffered by the Participants.

6.4 In the event mentioned above, the Promoter reserves the right to retain the entire registration fee and to use it for the organization of a new Forum Event.

6.5 In any case, the Promoter does not assume any responsibility and will therefore not be required to recognize any right to reimbursement:

- For any problem of access, impediment or malfunction related to technical or IT tools, telephone line or internet connection, hardware or software components or any other cause not attributable to the Promoter that may result in not registering or participating in the Forum Event and related activities.

There are no reductions on the participation fee (350 euro) to the Forum program.

The activities will be held mainly in English. The Promoter reserves the right to organize activities in Italian where the need/ opportunity arises.

Information for the publication of data

Information pursuant to art. 13 of D. Lgs. n. 196/2003 and art. 13 of EU Regulation 2016/679 on the protection of individuals with regard to the processing of personal data. 1. The data of the persons in charge shall be processed, with or without the aid of electronic means, only for such time as is strictly necessary for the performance of the contract.
2. The data will be processed for the fulfillment of the obligations provided by the laws, regulations and Community legislation, or provisions issued by authorities legitimated by the law or by supervisory and control bodies, in paper and computer mode. The provision of data is mandatory and any refusal to provide such data may make it impossible to establish relations with the Foundation.
3. At the end of the contractual period, the data shall be stored in the Foundation's archive and shall be accessible in accordance with the relevant provisions in force.
